- The Kapatagan Water District now invites bids for the above Procurement Project. Bidders should have completed, within two (2) years prior to the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents.
- Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is open to all interested local bidders subject to the conditions for eligibility provided in the 2016 revised IRR of RA No. 9184.

4. Prospective Bidders may obtain further information from Kapatagan Water District and inspect the Bidding Documents at the address given below during office hours from 8:00am to 5:00pm (Mondays to Fridays) except for holidays.
5. A complete set of Bidding Documents may be acquired by interested Bidders on December 15, 2023 to December 22, 2023 from the given address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of FIFTY THOUSAND PESOS ONLY (PHP25,000.00). The Kapatagan Water District shall allow the bidder to present proof of payment for the fees in person, by facsimile or through electronic means.
6. Kapatagan Water District will hold a Pre-Bid Conference on December 22, 2023, 9:00AM at the Kapatagan Water District Office, Poblacion, Kapatagan, Lanao del Norte. Pre-Bid Conference shall be open to all prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before January 10, 2024. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
9. Bid opening shall be on January 10, 2024 at Kapatagan Water District Office, Poblacion, Kapatagan, Lanao del Norte. Bids will be opened in the presence of the bidders representatives who choose to attend the activity.

The Kapatagan Water District reserves the right to reject any all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
